3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
5. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. However, eligible micro and small enterprises will be allowed to participate .In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.
6. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY.
7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. ### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

### 2. Generic

After award of contract – Successful Bidder shall have to get Detailed Design Drawings approved from buyer before starting fabrication. Successful Bidder shall submit Detailed Design Drawings for Buyer's approval, within 5 days of award of contract. Buyer shall, either approve the drawings or will provide complete list of modification required in the drawings within 5 days. Seller shall be required to ensure supply as per approved Drawings with modifications as communicated by Buyer. If there is delay from buyer side in approval of drawing- the delivery period shall be refixed without LD for the period of delay in approval of Drawing.

### 3. Generic

### 6. Generic

**11. Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

All items as per BoQ to be supplied to the Station in-charge Chudeshwar VTS radar station. Items will be taken/ issued from station in-charge and remaining items, if any, will remain with station.

The street light poles to be in single Pipe as specified, no joint in the pole to be permitted.

The entire system shall be as per technical specifications and measurements mentioned. All items mentioned in BoQ shall be as per mentioned specification, good quality and marked with ISI standard.

The electric power supply to all the electric poles will be through individual armored power cable which should be laid underground. At some places cable has to be laid crossing metaled / concrete roads underground through high quality galvanized iron pipes. The ground/ road surface to be leveled and repaired after laying of UG cable.

Cable should be laid 1 foot underground. While lying of cable, it should not get damaged/ break by any corner of rock or excavation tools. In rocky area sand should be used below and above the cable as a protection to avoid damage of cable. The routing of the cable must be marked with marking stones at regular interval for tracing of the cable route.

Provision for separate main switches/ MCBs for switching on Circuit 1 and Circuit 2 to be made in power house of the station.

AC Power supply distribution to each location of street lights along with DBs, JBs, cabling work etc. with required accessories has to be executed.

All street lights poles to be thoroughly painted (Two coat Red Oxide and Two Coat Silver Paint) and installed as per the attached drawing.

Supervisory specialist/ technician of related field at the site has to be provided to assist in all phases of installation, testing and commissioning.

The entire system shall be installed and commissioned by a single vendor to assure reliability and continued service. Subletting of contract will not be permitted.

The main components for Quality assurance of the system should get prior approval from the competent authority.

The contractor shall be responsible for inspection and Quality Assurance (QA) for a material and workmanship furnished.

No extra cost shall be paid for miscellaneous items if required to complete the work as per the design.

The contractor has to make their own water arrangement for the work.

The price quoted by the vendor should include all the expenses incurred in supply, testing and commissioning of all items, digging and laying of cables, accessories and other devices complete as required.

The contractors are advised to visit the site for assessing the feasibility / nature of the work before bidding.

## 12. **Turnover**

OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

#### 15. **Warranty**
