1. The work should be carried out and completed within 20 days to the entire satisfaction of the Director or his authorized representative from the date of work order to be issued.
2. The items supplied should be confirmed to the Bureau of Indian standard wherever applicable.
3. The undersigned reserves the right to reject the work contract at any time without assigning any reason there off.
4. The bidder shall study thoroughly the concept of work enclosed as per NIQ before quoting their rates.
5. The lowest quoted bidder shall have no right to claim the award of work, for which Director's decision is final.
6. The quantity shown in the schedule is approximate and the right to increase/ decrease the quantity rests with the Director, Directorate of Lighthouses & Lightships, Chennai without extra liability to the department.
7. The contractor shall, at his own cost, provide all tools and scaffolding items what ever required for the work and arrange water facilities for the workers and all other services required for the execution of work at site.
8. The contractor shall satisfy himself in regard to the nature of work to be done and its scope etc
9. No extra work shall be entertained except when such work has been authorized in writing by the Director, or his representative.
10. If the contractor shall desire an extension of time for completion of work on the ground of unavoidable circumstances, he shall apply in writing to the Director, Department of Lighthouses & Lightships, Chennai within five days from the date of occurrence of hindrance on account of which extension of time is desired. If at the opinion of the Director, the reason shown by the

contractor appears to be reasonable, he may grant such extension of time for a reasonable period.

11. The payment will ordinarily be made in final account bill basis for the actual quantity of work carried out and measured by the site in charge.
12. No escalation charges will be permitted under any circumstances.
13. Any loss to men and materials during the course of work shall be the responsibility of the contractor, the department will not take any responsibility in this regard.
14. The contractor shall observe all conditions laid in labour law in force.
15. The contractor shall not pay less than fair wage to labourers engaged by him on the work.
16. No labourer below the age of eighteen years shall be employed
