TERMS & CONDITIONS

- 1) The blank quotation form shall be collected from the office of Directorate of Lighthouses & Lightships, Cochin from **20.04.2024 to 29.04.2024** on all working days between **1000 hrs to 1600 hrs**. The last date & time for issue of blank quotation form on **29.04.2024 till 1600 hrs**.
- 2) The sealed quotation superscribed with Name of work: **"Replacement of broken glass panel of lift well with SS plate at Thangasseri Point LH"** shall be submitted on or before **30.04.2024 up to 1500 hrs** through Indian post/ courier or by hand to the Director, Directorate of Lighthouses and Lightships, Cochin. The quotations shall be addressed to "Director, Directorate of Lighthouses and Lightships, Cochin. The offer submitted in enclosed schedule received on or before due date and time shall only be considered.
- 3) The successful bidder shall be decided based on lowest amount quoted by the bidder.
- 4) The address given in the bid shall be deemed to be bidders address and any correspondence sent on that address shall be considered to have been delivered to the bidder. No claim shall be entertained for the reason of forfeiture of the sum deposited in case the correspondence is received back undelivered.
- 5) The lowest bid, once accepted, is not transferable to anyone. In case the bidder is a company, the name of the company should be indicated as the bidder. In such cases, the person appearing on behalf of the company shall have to produce the authorization letter in a proper format issued from a competent authority of the company. Any request to change the name of the bidder in the bid after submission of the bid shall not be entertained.
- 6) The scheduled day for opening the sealed bids, if declared to be holiday due to any reason, the same shall be opened on same working day at **1600 hrs**.
- 7) The bidders shall quote the amount, both in words and in figures. If there is any difference between the amount given in figures and that of in words, the rate quoted in words alone shall be considered and accepted on record.
- 8) The rates shall be quoted in the enclosed schedule marked as Annexure-I. Rates quoted in other form shall not be accepted.
- 9) The rate quoted shall be including all materials, labours , fabrication, loading, transporting, scaffolding and any other charges etc & inclusive of GST.
- 10) The work shall be carried out and completed to the entire satisfaction of the Director or his authorized representative.
- 11) The quantity shown in the schedule is approximate and the right to increase/ decrease the quantity rests with the Director, Directorate of Lighthouses & Lightships, Cochin without extra liability to the department.
- 12) The contractor shall, at his own cost, provide all tools, whatever required for the work except that items which will be supplied by the department and arrange water facilities for the workers and all other services required for the execution of work at site.
- 13) The contractor shall satisfy himself regarding the nature of work to be done, its scope etc., the conditions of contract, specification, schedule etc. before offering their rates.
- 14) No extra work shall be entertained except when such work has been authorized in writing by the Director, or his representative.
- 15) If the contractor shall desire an extension of time for completion of work on the ground of unavoidable circumstances, he shall apply in writing to the Director, Department of Lighthouses & Lightships, cochin within five days from the date of occurrence of hindrance on account of which extension of time is desired. If at the opinion of the Director, the

reason shown by the contractor appears to be reasonable, he may grant such extension of time for a reasonable period.

- 16) The payment will ordinarily be made in running account bill basis for the actual quantity of work carried out and measured by the site in charge in time to time.
- 17) The work shall be commenced immediately on receipt of work order from this office and shall be completed within 20 days from the date of issue of work order.
- 18) No escalation charges will be permitted under any circumstances.
- 19) Any loss to men and materials during the course of work shall be the responsibility of the contractor, the department will not take any responsibility in this regard.
- 20) The bidder should follow all the instruction & guidelines related to safety & operational, issued by the Director, Directorate of Lighthouses and Lightships, Cochin or his representative.
- 21) The successful bidder shall observe and perform all the rules, regulations and orders of the Government or any local authority.
- 22) It will be the contractor's responsibility to ensure all safety measures for the workers and to maintain proper discipline inside the lighthouse premises.
- 23) The contractor shall observe all conditions laid in labour law in force.
- 24) The contractor shall not pay less than fair wage to labourers engaged by him on the work.
- 25) No labourer below the age of eighteen years shall be employed.
- 26) The contractor shall be responsible for any accidents or damages to the work during construction and he shall restore and make good such injury/damage of structure at his own expense.
- 27) The contract shall be governed by the law of the India. Lawsuits and other proceedings arising out of or in connection with the contract shall be instituted in Courts of law at Ernakulam/ Cochin only.
- 28) The interested bidders may inspect the said site from **20.04.2024** onwards between **10:00** hrs to **1600 hrs** on all working days till **29.04.2024,16:00** hrs.
- 29) The Director, Directorate of Lighthouses & Lightships, Cochin reserve the right to reject any or all the bids without assigning any reasons. The Director, Directorate of Lighthouses & Lightships, Cochin also reserves the right to withdraw the said "**Replacement of broken glass panel of lift well with SS plate at Thangasseri Point LH**" from the bid without assigning any reasons thereof. The decision of the Director, Directorate of Lighthouses & Lightships, Cochin shall be final in this regard during the process of this at any stage.
