TERMS AND CONDITIONS

1. **Eligibility criteria:** The following documents shall be submitted to the Director, Directorate of Lighthouses & Lightships, Chennai along with quotation.
 - i) Experience regarding same type of repair work for any other Govt. Organization / reputed private firms.
 - ii). Photocopy of PAN Card, Income tax return for last three financial years.
 - iii). Photocopy of Business registration certificate from the local authority.
2. The bidder shall study thoroughly the concept of work enclosed with quotation form before quoting their rates.
3. The rate shall be inclusive of all labour charges, cost of all materials, tools & plants, transportation and all other charges. No other payment shall be made other than the accepted rate.
4. The bidder shall submit an Earnest money deposit of Rs.2440/- in the form of Demand draft obtained from any scheduled bank in favour of Director, Directorate of Lighthouses & Lightships, Chennai payable at Chennai along with filled quotation. The EMD of successful bidder shall be returned after successful completion of work. The EMD of unsuccessful bidders shall be returned 7 days after opening of bids.
5. The lowest quoted bidder shall have no right to claim the award of work, for which undersigned decision is final.
6. The right to accept or reject any or all quotations reserves with the undersigned.
7. The quotation shall be of unconditional one.
8. The work shall be completed within 30 **days** from the date of acceptance of work order by the bidder.
9. Time being the essence of the contract; Contractor should take all the steps to complete the work within the stipulated time.
10. The department is not responsible for any loss or damage occurred due to any accident of the labourers engaged by the contractor during the execution of the work and the contractor will be solely responsible for the same.

11. All the materials, tools and plants to be arranged by the Contractor at his own cost.
12. The quantities given in the schedule are only approximate. The payment will be made for the actual quantity of works carried out by the Contractor after making measurement.
13. The payment of the bill will be made within 30 days from the date of receipt of bills in this office. No advance payment shall be made.
14. Income tax, and all other taxes shall be deducted as per Govt. rules.
