- 1) Supply of the materials to the site & The work should be carried out at the site Manakkodam Lighthouse, Andhakaranazhi P.O., Pattanakkadu, Alleppey (Dist), Pin: 688 531, Including Loading, Unloading and Freight charges.
- 2) Dismantling, Installation, Integration and Commissioning of the LT panel, AMF panel, Stabiliser, etc., should be carried out by your technical personnel in presence of department representative at site.
- 3) Dismantling, Installation, Integration and Commissioning of the 7.5kVA DG set & 5kW Solar plant should be carried out by your technical personnel in presence of department representative at site.
- 4) Shifting of the DG set, Solar Panels, Stands, LT panel, stabilizer, AMF panel, etc., either by manual labour or mechanical means from existing temporary power house to New Powerhouse.
- 5) Integration of various Lighthouse loads such as water pump, tower lighting, Main Light, Automation, etc., associated earlier with the Power House should be carried out through existing cabling to the power house.
- 6) Escalation of rate for men and materials etc. will not be considered & given on any account.
- 7) Necessary tools, equipment, etc., for works shall be arranged by you.
- 8) Electrical Energy required for the work shall be supplied at site by this office, except for those mentioned in your Quotation
- 9) You have to fulfil all relevant labour act & laws and fully responsible for the safety of labourers engaged by you. The department will not be held responsible for any claim for injuries or loss of life, what so ever for the labourers engaged by you.
- 10) Escalation of rate for men and materials etc. will not be considered & given on any account.
- 11) The rate for all items of work shall, unless clearly specified otherwise, included cost of all materials, labour, and other inputs involved in the execution of work.

- 1) Filled quotation shall be forwarded in a sealed cover duly superscribed **“Re-Shifting of Temporary Powerhouse to new Powerhouse at Manakkodam Lighthouse”** so as to reach this office on or before 1500 hours on 15.07.2024, which shall be opened on 15.07.2024 (1600 hours).
- 2) The bidders may visit the concerned lighthouse at their own cost to familiarize with the site before quoting the bid. The cost associated with preparation and submission of quotation shall be borne by the bidder. The cost of stamp duties and similar charges (if any) imposed by laws in connection with entry into the contract agreement shall be borne by the bidder.
- 3) The bidder shall complete the schedule of works as attached stating item wise, unit price and the total amount. The rate shall indicate the basic cost and other taxes separately.
- 4) Price quoted by the bidder shall remain firm and valid until completion of Contract performance.
- 5) All the rates and amount shall be quoted in whole denomination of the Indian Rupee. The rate of each item shall be quoted in figures and word. In case of any error, the rate in word shall be valid and taken into account for calculation of amount.
- 6) No amount shall be paid to the Contractor for the item for which no rate or amount is quoted by the Bidder, but the contractor shall be bound to do that job/ work free of cost (on zero amount).
- 7) The items to be used, shall be of standard reputed make and conform to the Indian standard specifications or relevant KSEB specifications as applicable.
- 8) All items mentioned in schedule, shall be of good and working condition, if desired the department representative may inspect for observing condition of the items. Warranty in respect of each item shall clearly be specified.
- 9) The offer shall remain valid for 60 days from the date of opening of quotations.
- 10) The work shall be carried out without any interruptions to the normal working of the Lighthouse Equipment.
- 11) The following documents to be submitted along with sealed quotation:
 - a) Valid Electrical License from KSEB
 - b) NSIC/MSME registration certificate or EMD.
 - c) PAN card.
 - d) GST Registration Certificate.
 - e) Work Experience of equivalent/similar works or higher value of NIQ (Work completion etc.)
 - f) Last 3 years income tax returns.Non Submission of any of above credentials shall render the quotation liable for rejection.
- 12) The L1 bidder shall be decided on the consolidated lowest total of the schedule of work.
- 13) The successful bidder shall be required to submit a Performance Guarantee in the prescribed format (fixed deposit receipt/ Bank guarantee from a schedule bank in India), equivalent to 10% (Ten percentage) of the contract value, within 10 (Ten) days after notification of the award. The Performance Guarantee shall be initially valid up to the stipulated date of completion plus minimum 60 days beyond the date of completion of all contractual obligations of the contractor, including Defect Liability Period (DLP). In case the time for completion of work gets enlarged, the contractor shall get the validity of Performance Guarantee extended to cover such enlarged time for completion of work. After recording of the completion certificate for the work by the competent authority, the performance guarantee shall be returned to the contractor, without any interest.

- 14) The Earnest Money Deposit of the unsuccessful bidders will be returned at the earliest after expiry of the final bid validity period and latest by the 30th day after the award of the contract, without any interest. EMD of the successful bidder will be refunded without any interest after receipt of a valid Performance Guarantee, subsequent its verification and signing of contract agreement.
- 15) If the successful bidder failed to submit the performance security of requisite amount within specified period, extended if any, the EMD of the successful bidder shall be liable for forfeiture and the contractor shall be black listed for three years.
- 16) The performance security will be refunded to the contractor without interest, after he duly performs and completes all obligations under the contract. The performance security will be forfeited and credited to the Director's account in the event of a breach of contract by the contractor, if the contractor failed to commence the work within stipulated time.
- 17) The contractor shall execute and complete the works in accordance with the contract, and he shall remedy the defects, if any, in the works.
- 18) The Agreement will incorporate all correspondences between the Director and the successful bidder. It will be signed by the Director and successful bidder within 15 days following the notification of award along with the Letter of Acceptance.
- 19) The work shall be carried out to the entire satisfaction of the Director or his representatives.
- 20) The work shall be completed within 45 days from the date of issue of work order. The commencement of work shall be counted from the date of issue of Work Order.
- 21) The payment shall be made as below:
100% payment of the contract amount shall be made within 30 days from the satisfactory installation/ completion of work. Income tax shall be deducted as per the provisions of income tax act.
- 22) If the contractor fails to maintain the required progress or to complete the work and clear the site on or before the contract or justified extended date of completion (excluding any extension) as well as any extension granted, he shall, without prejudice to any other right or remedy available under the law to the Government on account of such breach, the contractor shall pay as compensation the amount equal to 0.50% of the contract value of the work for every week that the progress remains below or that the work remains incomplete subject to a maximum of ten percent of contract value or such smaller amount as may be decided by the Director, whose decision in writing shall be final and binding. The department will not be required to submit the estimated loss due to delay of work.
- 23) In case, it appears to the Director at any time during the progress of the work, that the progress and the quality of the work is unsatisfactory he shall have full powers to employ such extra labour as he may consider necessary for the proper progress and the quality of the work and shall debit the cost of such labour to the contractor, which shall be the first charge upon bills of the contractor.
- 24) In the event of the firm going into liquidation or winding up his business or making arrangement with his creditors, this agreement shall stand ipso facto terminated from the date of occurrence of such event. This termination shall be without prejudice to any other rights to remedies, available to the DLL under this agreement. In the event of any breach of terms and conditions of this Agreement or un-satisfactory performance of the contractor, the Director shall have the right to terminate the agreement forthwith by giving 30 days' notice. The decision of the Director under this clause shall be final. The performance Guarantee submitted by the firm also be forfeited on failure to execute the work as per

terms and condition of this tender document and contractor shall be black listed for three years.

- 25) The Director, Directorate of lighthouses and Lightships, Cochin reserves the right to cancel the contract if the contractor is found not working according to the terms and conditions, and he will be liable to make good of the losses of the department due to the breach of any of the terms and conditions of the contract for the period up to the date of actual termination of the contract.
- 26) The contract shall be governed by the law of the India. Lawsuits and other proceedings arising out of or in connection with the contract shall be instituted in Courts of law at Ernakulam/ Cochin only. All labour laws (state/ central/ local Authority) shall be followed fully by the contractor at his own cost.

TECHNICAL SPECIFICATION

Brief Technical Specifications

- i.) All wiring works must be carried out as per K.S.E.B specifications and standards. Whenever KSEB specifications are not available, the works must be carried out as per CPWD GENERAL SPECIFICATIONS FOR ELECTRICAL WORKS 2013 PART-I INTERNAL.
- ii.) All Electrical works shall be carried out in accordance with the provisions of Indian Electricity Act, 2003 and Indian Electricity Rules, 1956 amended up to date.
- iii.) All Electrical works shall be carried out in consultation with the DLL or his representative. Approval shall be obtained for any justified modifications in the work from DLL before execution of the works.
- iv.) All KSEB Energy Meters are to be placed in appropriate Meter Boxes on the location as specified by the KSEB regulations. The Service connections to the Meters have to be ensured by the Electrical Contractor after the completion of works.
- v.) Necessary documents for reconnection must be prepared by Electrical Contractor and submitted to KSEB. The Electrical Contractor should ensure the Mains Supply is available before occupation by the residents.
- vi.) Any payments made to KSEB in connection with the temporary connection, shifting of meters, reconnection, Security Deposit, etc., if not included in the BoQ, can be claimed separately by the Electrical Contractor after the submission of the appropriate receipts to this office.

- vii.) All wires/conductors shall be of copper conductors only with fire-resistant insulation and appropriate IP rated wherever applicable. The items shall conform to relevant BIS/ISI/IEC standards wherever applicable.

We _____ (Name & Address of the bank) having its Head office at _____ (hereinafter referred to as the "Bank" which expression shall, unless repugnant to the context or meaning thereof, include its successors, administrators, executors and assignees) do hereby guarantee and undertake to pay the DLL, on mere demand any and all moneys payable by the Electrical Contractor to the extent of ₹ _____* as aforesaid at any time up to _____ (day/month/year) without any demur, reservation, contest, recourse or protest and/or without any reference to the Electrical Contractor. Any such demand made by the DLL on the Bank shall be conclusive and binding notwithstanding any difference between the DLL and the Contractor or any dispute pending before any Court, Tribunal, Arbitrator or any other authority. The Bank undertakes not to revoke this guarantee during its currency without previous consent of the DLL and further agrees that the guarantee herein contained shall continue to be enforceable till the DLL discharges this guarantee.

The DLL shall have the fullest liberty without affecting in any way the liability of the bank under this guarantee, from time to time to extend the time for performance of the contract by the Electrical Contractor. The DLL shall have the fullest liberty, without affecting the guarantee, to postpone from time to time the exercise of any powers vested in them or of any right which they might have against the Electrical Contractors, and to exercise the same at any time in any manner, and either to enforce or to forbear to enforce any covenants, contained or implied in the Contract between the DLL and the Electrical Contractor or any other course or remedy or security available to the DLL. The bank shall not be released of its obligations under these presents by any exercise by the DLL of its liberty with reference to the matters aforesaid or any of them or by reason of any other act or forbearance or other acts of omission or commission on the part of the DLL or any other indulgence shown by the DLL or by any other matter or thing whatsoever, which under law would, but for this provision, have the effect of relieving the bank.

The bank also agrees that the DLL at its option shall be entitled to enforce this Guarantee against the Bank as a principal debtor, in the first instance without proceeding against the Electrical Contractor and notwithstanding any security or other guarantee that the DLL may have in relation to the Electrical Contractor's liabilities. We undertake to pay to the Government any amount so demanded by the Government, notwithstanding any dispute or difference between the Government or the Electrical Contractor or any other person or between the Electrical Contractor or any person or any suit or proceeding pending before any court or tribunal or arbitration relating thereto; or the invalidity, irregularity or unenforceability of the Electrical Contractor in any other circumstances which might otherwise constitute discharge of this Guarantee, including any act of omission or commission on the part of the Government to enforce the obligations by the Electrical Contractors or any other person for any reason whatsoever.
