नोट/Note :

2. Earnest Money Deposit shall be furnished in the form of Demand Draft or FDR from any Nationalized Bank, in favour of "The Director of Lighthouses and Lightships, Mumbai" payable at Mumbai as mentioned above. EMD in any other form shall not be accepted. Validity of the EMD shall be 90 days from the date of publishing of tender.
3. The details of work are available in the tender document which can be downloaded from <http://eprocure.gov.in/eprocure/app>. Sale of physical tender document is not applicable. The bid should be submitted online only on <http://eprocure.gov.in> up to last date and time of submission of tender.
4. The EMD shall be submitted in original to the Tender Inviting Authority, on or before the stipulated timelines, failing which the tender shall be liable to be rejected. DLL, Mumbai shall not be responsible for any delay or loss due to postal/Courier Services.
5. Bidders who are micro and small enterprises (MSEs), registered with Micro Small Medium Enterprises (MSME) or National Small Industries Corporation (NSIC) or any other body specified by Ministry of MSME for similar nature of Works shall be eligible for exemption from payment of EMD as per the prevailing guidelines issued by the Government of India. They are required to submit documentary proof of such registration along with duly filled "Bid Security Declaration Form" as per Annexure – I. The NSIC / MSME certificate and Bid Declaration Form shall be submitted along the technical bid for claiming the exemptions.
6. If the Registration Certificate or certificate issued for the works does not pertain to "Similar Works" and / or non-submission of Bid Security Declaration Form, such exemption shall not be granted and their Bid will be liable to be rejected.
7. MSMEs, which are specified by the Ministry of Micro, Small and Medium Enterprises under MSME Act 2006 and Public Procurement Policy, 2012 as Manufacturing / Service Enterprises should have registered with NSIC under its Single Point Registration Scheme (SPRS).

8. Medium Enterprise with annual turnover exceeds Rs.50 Crores shall not be considered for availing exemption from payment of EMD.
9. The items of works / Services mentioned under MSME / NSIC certificate should be the same or similar work of tender.
10. The MSME/NSIC certificate along with Bid Security Declaration form shall not be considered as shortfall document.
11. Director, Directorate of Lighthouses & Lightships, Mumbai reserves the right to accept/reject the bid and cancel/postpone the tenders at any stage of the Bid, without assigning any reason, which shall be binding on all Bidders.
12. Those Bidders whose near relatives are posted as accountants or as a Gazetted Officer in any capacity in the Directorate General of Lighthouses & Lightships shall not be permitted to Bid. The prospective Bidder shall also intimate the names of persons who are working in the office of Director of Lighthouses and Lightships, Mumbai in any capacity or subsequently employed, who are near relative to any Gazetted officer in the DLLs/DGLL or in the Ministry of Ports, Shipping and Waterways. Any breach of this condition by the bidder shall render him ineligible. By the term 'near relative' is meant wife, husband, parents & grandparents, children & grandchildren, brothers & sisters, uncles, aunts & corresponding in laws.
13. No Gazetted Officer of Government of India is allowed to work as a contractor without prior permission of the Govt. of India in writing for a period of two years after his retirement from government service. The contract is liable to be cancelled if either the contractor or any of his employees is found at any time to be such a person who had not obtained the permission of Govt. of India as aforesaid, before submission of the Bid or engagement in the contractor's service.
