#### Section – I

1) The contractor (The manufacturing agency of lift) should have valid license/ registration issued by the State CEIG or any other licensing authority of State/ Central Government having experience in similar work like fabrication and erection of structural steel tower for providing lift and installation of lift.

OR

The contractor should have valid registration in appropriate category and class with CPWD/ State PWD/ Railways/ MES/ BSNL etc or with any other State/ Central Government/ Public Sector Undertaking/ Autonomous bodies & having Joint Venture Consortium with Lift manufacture agencies to carry out similar nature of work.

- 2) Proof of satisfactory completed similar works during last 7 (seven) years ending on the last day of the month previous to the one in which, the tenders are invited, shall have any of the following.
  - (a) Three similar completed works costing not less than the amount equal to 40 (forty) percent of the estimated cost; or
  - (b) Two similar completed works costing not less than the amount equal to 50 (fifty) percent of the estimated cost; or
  - (c) One similar completed work costing not less than the amount equal to 80 (eighty) percent of the estimated cost (For experience "only those works which had been completed in all respects and completion certificate is issued" shall be considered).

## Similar work shall mean:

"Supply, Installation testing and Commissioning of elevator"

OR

**For Joint Venture Consortium:** Any type of civil engineering works like RCC tower, steel structures, multi-storeyed building, bridge, water tank etc. for First Party and the experience of the lift manufacturing agency (Second Party) will be taken into account.

Copies of original documents defining the legal status, place of registration, principal place of business, written power of attorney of the signatory of the bidder to commit the bid for First & Second party. The second party should submit copy of the manufacturing license CEIG certificate.

A member of **Joint Venture** (JV) shall not be permitted to participate either in individual capacity or as a member of another **Joint Venture** (JV) in the same Tender.

### **TERMS AND CONDITIONS:**

- 01. Earnest Money Deposit of ₹1,49,100 /-shall be submitted in the form of Demand Draft/ Fixed Deposit receipt (FDR) issued from any Scheduled Bank in favour of "Director of Lighthouses and Lightships Cochin" payable at Ernakulam.
- 02. The originals of EMD (or MSME/ UDYAM/ NSIC Certificate) along with all technical documents shall be submitted to this office by Registered/ Speed Post or by personally on or before the schedule date & time for submission date otherwise the uploaded bid shall be deemed to be rejected/ disqualified. Any postal delay will not be entertained.
- 03. The details of work are available in the tender document which can be downloaded from website Central Public Procurement (CPP) Portal <a href="https://eprocure.gov.in/eprocure/app">https://eprocure.gov.in/eprocure/app</a> and the bid is to be submitted online only on <a href="https://eprocure.gov.in/eprocure/app">https://eprocure.gov.in/eprocure/app</a> up to last date and time of submission of tender. Sale of physical tender document is not applicable.
- 04. Bidding is open to all eligible Bidders meeting the eligibility criteria as defined in clause 3.1. Bidders are requested to note and satisfy themselves that they fulfill eligibility criteria.
- 05. The date of technical bid opening is subject to the availability of internet. Hence, the technical bid opening date is at the jurisdiction of the director.
- 06. Technical evaluation shall be carried out by a Committee. On completion of technical evaluation only, the Commercial Bids of the technically qualified bidders shall be opened by the Committee. The decision of the Director, Directorate of Lighthouses & Lightships, Cochin in deciding the successful bidder shall be final and binding on the bidders.
- 07. The Bidder shall carefully read Eligibility Criteria & instructions to Bidders, Technical requirement & Scope of work, General& Special conditions of contract, and all other documents in connection with the Bid. The Bidder shall quote his rates, keeping all above points in mind.
- 08. The Director, Directorate of Lighthouses & Lightships, Cochin reserves to himself the right of accepting the bid or rejecting all bids, bidder shall be bound to perform the same at the quoted rates.
- 09. The Director, Directorate of Lighthouses & Lightships, Cochin reserves the right to himself for accepting or rejecting the bid. Bidder shall be bound to perform the same at the quoted rates.
- 10. Canvassing whether directly or indirectly, in connection with Bid is strictly prohibited. The Bids submitted by the Bidders, who resort to canvassing, shall be summarily rejected.
- 11. Those Bidders whose near relatives are posted as accountant or as a gazetted Officer in any capacity in the Directorate General of Lighthouses & Lightships shall not be permitted to Bid. The prospective Bidder shall also intimate the names of persons who are working with him in any capacity or subsequently employed by him, who are near relative to any gazetted officer in the DGLL or in the Ministry of Shipping. Any breach of this condition by the bidder shall render him ineligible. By the term 'near relative' is meant wife, husband, parents & grand parents, children & grandchildren, brothers & sisters, uncles, aunts & corresponding in laws.
- 12. No Gazetted Officer of Government of India is allowed to work as a contractor without prior permission of the Govt. of India in writing for a period of two years after his retirement from government service. The contract is liable to be cancelled if either the contractor or any of his employees is found at any time to be such a person who had not obtained the permission of

- 13. In the event of any specified date, being or declared as a holiday by the Government of India, the specified activities shall take place on or up to the appointed time on the next working day.
- 14. The Notice Inviting Bids, all types of corrigendum/addendum/terms and condition of tender etc. shall form the part of contract document.
