Only International numerical i.e., 1, 2, 3 etc. should be used. The application form should be filled strictly observing all the instructions given. The candidate should be affixing his/ her normal signature in the application form. Application signed in Capital / Spaced out letter will be treated as invalid.

c) The candidate's Name, Address with Pin Code, Date of Birth, Father's name etc. should be written legibly in English in bold Capital letters.

- .d) Photographs: One recent (not earlier than three months from the date of application) Color photograph of size 3.5cm x 3.5cm with clear visibility of face and a portion of shoulder should be pasted on the application form in the space provided. The background of the photo with white or light color is more preferable. The face should be at the Centre of the photography. The eyes shall be clearly visible in photo.
